e) All contestants must submit a copy of the song lyrics together with the application form upon registration.
f) In addition, contestants performing with the aid of Karaoke CDs must also submit 2 identical good quality CDs with audio tapings from a good sound system for use in the competition.
g) NO CHANGING OF SONG OR CD is allowed after registration.
